



Legislative Update March 3, 2023

SECTION 1: GENERAL

It was a short week at the Capitol as the assembly was in crossover recess Monday and Tuesday. Legislators began to tackle the 700 pieces of legislation that survived their chamber of origin on Wednesday. While short, it's been an extremely productive week as it relates to our opposition of SB 2217. You will recall that this bill was introduced by the retailer and grocer associations and seeks to prohibit charging interchange fees on the tax component of a credit or debit card transaction. It narrowly passed in the Senate. We need to kill it in the House as it's a bad bill with serious issues. ICBND, ICB Services, and NDBA have worked closely with the Electronic Payments Council (EPC) and its members to defeat this in the House. Representatives from Visa were in Bismarck Thursday, and we had meetings with most (10 of 14) of the House Finance and Taxation Committee members, House majority and minority leadership, the Governor's office, and other legislators. These were very productive meetings, and the Visa folks did an outstanding job articulating why this won't work and the problems associated with it.

ICBND members will again be asked to make their voice heard on this bill with House members – first targeting those on the Committee and ultimately the entire chamber. SB 2217 will be heard at 9:30 am on Tuesday, March 7 in the House Finance and Taxation Committee. Representatives from the EPC will be at the Capitol to testify in opposition along with ICBND, ICB Services, the Bank of North Dakota, NDBA, and hopefully others. And heck, who knows, maybe the credit unions will even make a cameo appearance. Excuse my sarcasm, but the credit union lobby has seemingly only cared about their field of membership bill while the banking community has been burning political capital on nearly every other financial institution issue. There will again be a parade of testimony in support of the bill, and I'd be surprised if the national retail lobby doesn't make their presence known as well as they are the driving force behind this issue in North Dakota and a number of other states.

Also to be heard Tuesday morning in the House Industry and Business Committee is Senate Bill 2263 which is ICBND's bill to amend North Dakota Century Code to align with the Real Estate Settlement Procedures Act (RESPA) as it relates to "surplus" in escrow accounts. SB 2263 passed through the Senate unscathed, and we hope for similar results in the House. We thank Senator Scott Meyer for being the lead sponsor on this bill.

SECTION 2: BILL UPDATES FROM ICBND "PRIORITY" TRACKING LIST

HB 1068 – is model legislation brought forth by DFI that would establish state regulation for non-depository mortgage loan servicers and would bring them under the DFI's supervision. Currently, this segment of the mortgage loan servicing industry is not regulated and represents 45 percent of the business nationwide. Several states have already implemented similar legislation and the DFI would work with those states in regulating this segment of the market. According to DFI, it would require two FTE's which would be paid for by those mortgage loan servicing companies. Only one of those FTE's was approved in the House so that issue will come up again in Appropriations. On Wednesday, the Senate Industry and Business Committee heard the policy bill and gave it a 4-0 "do pass" recommendation.

HB 1107 – this bill was brought forth by the Appraiser Board and relates to regulation of appraisers. Our primary concern with this bill was to make sure that it exempts the Bank of North Dakota (BND) and its evaluation and appraisal review business from oversight of the Appraiser Board. Through amendments brought by ICBND, we achieved that in the House. It was heard in the Senate Workforce Development Committee this morning to a full crowd. The Appraiser Board testified in support of the bill but continues to express concerns with the BND exemption. The North Dakota Appraiser Association (NDAA) offered amendments that would allow appraisers to do evaluations. Lise Kruse from the DFI offered another amendment that would prohibit extension of the Appraiser Board's oversight to evaluations. I testified on the bill supporting the amendments offered by NDAA and DFI. The Committee did not act on the bill.

SB 2090 – was also brought by DFI and modernizes ND Century Code for non-depository residential mortgage lenders and money brokers. One specific change is that an order becomes effective when issued rather than when served. The department has at times had difficulty serving entities with orders so this would hasten the effects of an order. The bill received an 8-0 "do pass" recommendation from the House Industry Business and Labor (IBL) Committee Wednesday. It passed by a vote of 79-6 on the House floor this afternoon.

SB 2092 – is another DFI bill that among other things allows for the voluntary liquidation of a credit union by its board and members. It also passed the House IBL Committee with a 9-0 "do pass" recommendation.

SB 2111 – was heard in House Transportation Committee Thursday morning and allows an "opt-in" option for electronic vehicle titling. The bill was brought by the ND DOT. ICBND testified in support of the bill, and it received a 10-4 "do pass" recommendation from the Committee. There was no opposition testimony. The four opposition votes in Committee came from far-right legislators who had no comments or questions during the hearing so I'm a bit puzzled by their vote. It seems that the general disdain for government often gets in the way of legislation that is good for business and the consumer. It passed on the House floor today by a vote of 74-11.

SB 2119 – is another DFI bill pertaining to non-depository entities. It is model language referred to as money transmission modernization. It was also heard in the House IBL Committee Wednesday. The Committee did not act on the bill as they want to take more time to digest it.
